Breite Strasse 3 in Düsseldorf consists of approximately 5,100 m<sup>2</sup> of rentable office and retail space,18 underground parking spaces, and 46 bicycle parking spaces. It is located in the centre of Düsseldorf's banking district. MOMENI had acquired the property from Canada Life in 2015 and completely repositioned it. The office space is 100% let to IWG Group, one of the world's leading providers of business center concepts. The office and retail property, which is also BREEAM-certified, is the eleventh purchase to HMG's open-ended real estate fund "HMG Grundwerte Deutschland Büro III."
